Market Outlook: U.S. ethanol prices ended last week 3.3 percent lower but are reversing those losses in early week trading, up 0.2 percent through Tuesday's close. Midwest wholesale rack ethanol prices were lower to end last week and are down 2 percent through Tuesday's market close to their last quote of 36.43 cents/liter (137.92 cents/gallon).

FOB Houston ethanol prices finished last week 1.6 percent lower and are down 2.5 percent through Tuesday's trading from Friday's close. FOB Houston ethanol prices are quoted at 35.62 cents/liter (134.84 cents/gallon). FOB Santos, Brazil anhydrous ethanol prices were lower last week; they are down in early week trading, falling 4.5 percent to 50.29 cents/liter (190.35 cents/gallon) through Tuesday's trading.


The FOB Gulf-Santos, Brazil ethanol spread has narrowed from last week's close through Tuesday's trading and is currently at-14.66 cents/liter (-55.51 cents/gallon).

MTBE prices fell 7.4 percent last week and have posted further losses in early week trading, down 6.2 percent from Friday's close through Tuesday's trading. MTBE's premium to FOB Houston ethanol has decreased from last week's report and stands at 8.61 cents/liter (32.60 cents/gallon).


BTX component prices were sharply lower last week and are continuing that trend through Tuesday's market close: Benzene is down 3.3 percent while Toluene is down 6.6 percent and Xylene is down 6.3 percent. The estimated weighted average aromatic price is currently 58.28 cents/liter (220.63 cents/gallon), down from last Friday's close. The BTX-Houston ethanol spread narrowed last week,


and the weighted average BTX price is 22.66 cents/liter (85.79 cents/gallon) higher than the FOB Houston ethanol price.


Gasoline and petroleum products were lower last week and are continuing that trend in early week trading. RBOB futures are down 16.6 percent to start the week while 84 octane RBOB (Houston) and 87 octane CBOB (U.S. Gulf) gasoline prices are down 9.2 and 19.8 percent, respectively. WTI futures are 16.6 percent lower at \$34.43/barrel while Brent futures are down 17.8 percent to \$37.22/barrel, from Friday close through Tuesday's close.





