Market Outlook: U.S. ethanol prices ended last week unchanged at 43.46 cents/liter (164.5 cents/gallon) but are up 1.4 percent from Friday as of Tuesday's close. Midwest wholesale rack ethanol prices were 0.8 percent higher to end last week and are up another 1.2 percent through Tuesday's market close to their last quote of 45.68 cents/liter (172.9 cents/gallon).


FOB Houston ethanol prices finished last week 4.5 percent higher and are up 0.8 percent through Tuesday's trading from Friday's close. FOB Houston ethanol prices are quoted at 46.61 cents/liter (176.45 cents/gallon). FOB Santos, Brazil anhydrous ethanol prices were higher last week; they are up in early week trading, rising 1.3 percent to 49.11 cents/liter (185.915 cents/gallon) through Tuesday's trading.

The FOB Gulf-Santos, Brazil ethanol spread has widened from last week's close through Tuesday's trading and is currently at -2.5 cents/liter (-9.47 cents/gallon).


MTBE prices rose 1.6 percent last week and are extending those gains in early week trading, up 1.4 percent from Friday's close through Tuesday's trading. MTBE's premium to FOB Houston ethanol has increased from last week's report and stands at -1.92 cents/liter (-7.29 cents/gallon).


BTX component prices were mixed last week but are sharply higher through Tuesday's market close: Benzene is up 3.8 percent while Toluene is up 2.7 percent, and Xylene is up 2.2 percent. The estimated weighted average aromatic price is currently 57.5 cents/liter (217.66 cents/gallon), up from last Friday's close. The BTX-Houston ethanol spread widened last week, and the weighted average BTX price is 10.89 cents/liter (41.21 cents/gallon) higher than the FOB Houston ethanol price.


Gasoline and petroleum products were sharply higher last week and are extending those gains that trend in early week trading. RBOB futures are up 1.1 percent to start the week while 84 octane RBOB (Houston) and 87 octane CBOB (U.S. Gulf) gasoline prices are up 0.9 and up 1.6 percent, respectively. WTI futures are 2.7 percent higher at \$58.4/barrel while Brent futures are up 2.9 percent to \$61.09/barrel, from Friday through Tuesday's close.





