**Market Outlook:** U.S. ethanol prices ended last week 2.5 percent lower but are erasing those losses in early week trading, up 5.2 percent through Tuesday's close. Midwest wholesale rack ethanol prices were higher to end last week and are up 1.6 percent through Tuesday's market close to their last quote of 65.55 cents/liter (248.14 cents/gallon).

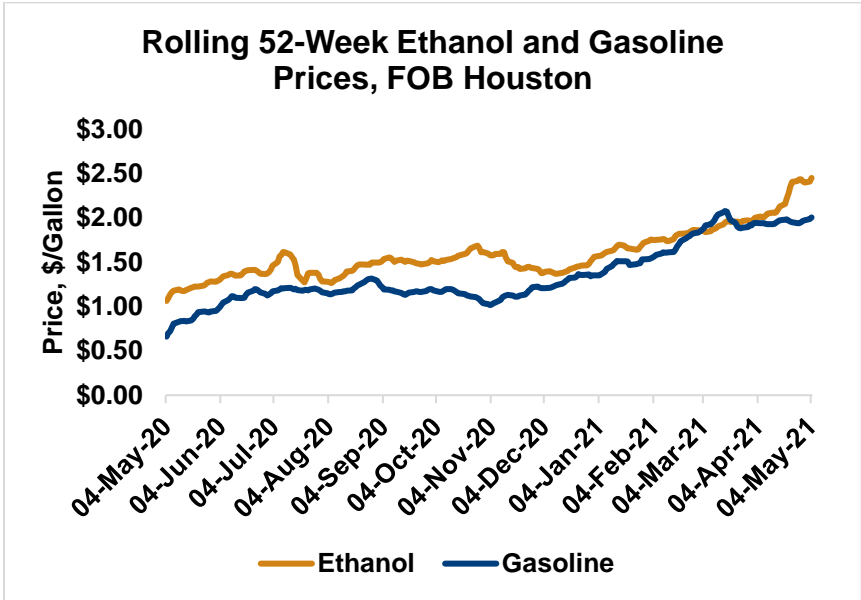
FOB Houston ethanol prices finished last week 6 percent higher and are up 1.3 percent through Tuesday's trading from Friday's close. FOB Houston ethanol prices are quoted at 64.76 cents/liter (245.15 cents/gallon). FOB Santos, Brazil anhydrous ethanol prices were higher last week; they are up in early week trading, rising 5.2 percent to 61.39 cents/liter (232.4 cents/gallon) through Tuesday's trading.

The FOB Gulf-Santos, Brazil ethanol spread has narrowed from last week's close through Tuesday's trading and is currently at 3.37 cents/liter (12.75 cents/gallon).

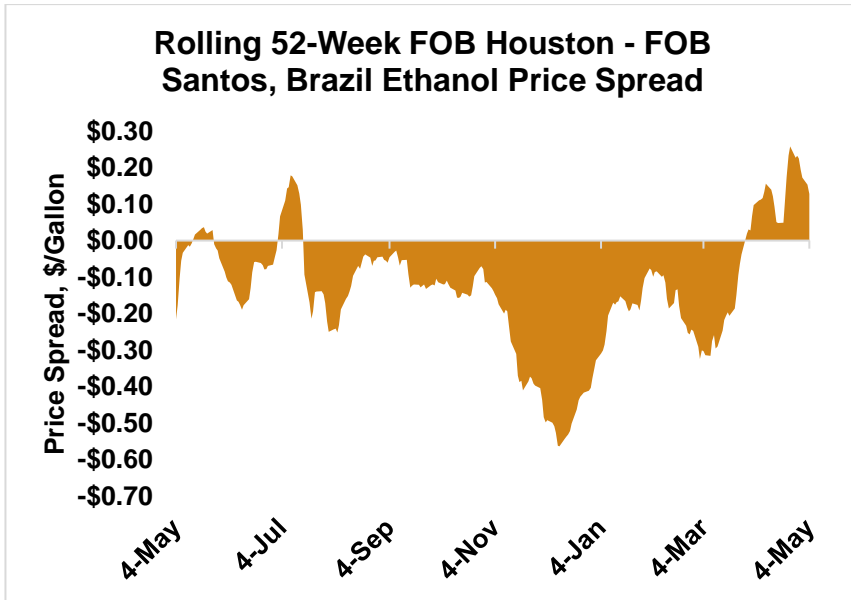
MTBE prices fell 0.5 percent last week but are sharply higher in early week trading, up 3.5 percent from Friday's close through Tuesday's trading. MTBE's premium to FOB Houston ethanol has increased from last week's report and stands at -6.5 cents/liter (-24.62 cents/gallon).

BTX component prices were mixed last week and are continuing that trend through Tuesday's market close: Benzene is down 9 percent while Toluene is up 1.8 percent, and Xylene is up 0.6 percent. The estimated weighted average aromatic price is currently 74.17 cents/liter (280.77 cents/gallon), down from last Friday's close. The BTX-Houston ethanol spread narrowed last week, and the weighted average BTX price is 9.41 cents/liter (35.62 cents/gallon) higher than the FOB Houston ethanol price.

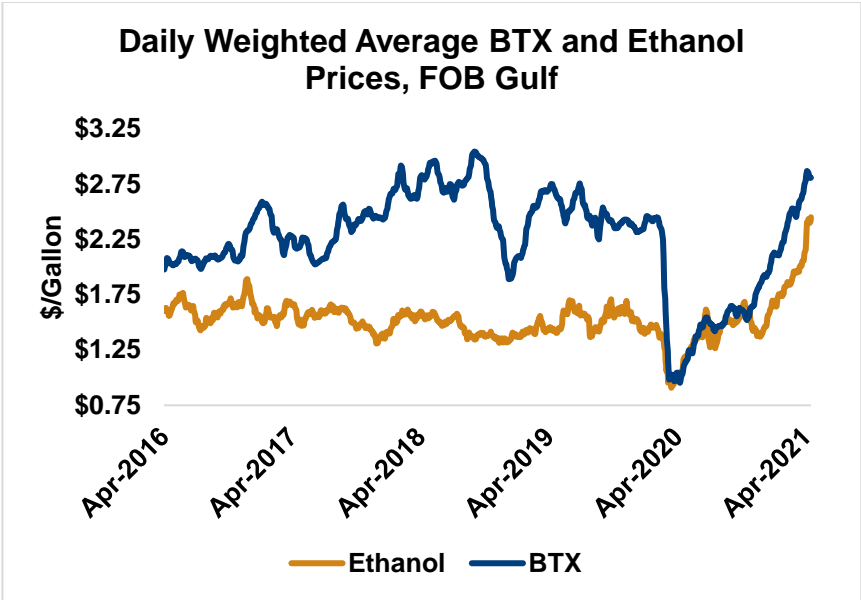
Gasoline and petroleum products were higher last week and are extending that rally in early week trading. RBOB futures are up 3.6 percent to start the week while 84 octane RBOB (Houston) and 87 octane CBOB (U.S. Gulf) gasoline prices are up 3.7 and up 1.2 percent, respectively. WTI futures are 3.3 percent higher at \$65.69/barrel while Brent futures are up 4.1 percent to \$69.49/barrel, from Friday through Tuesday's close.



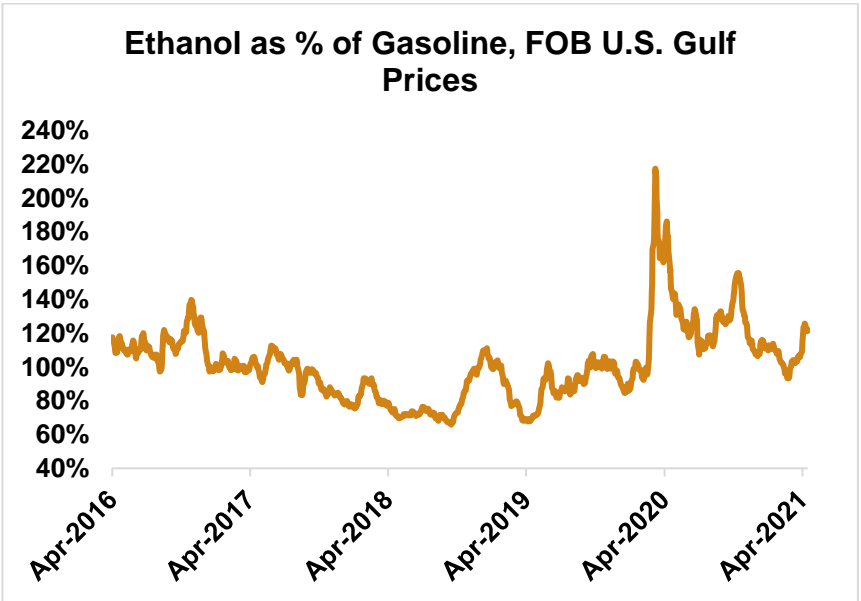

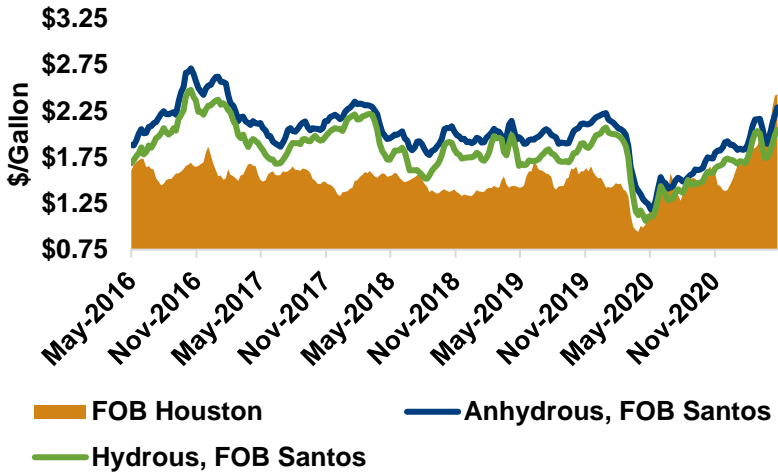

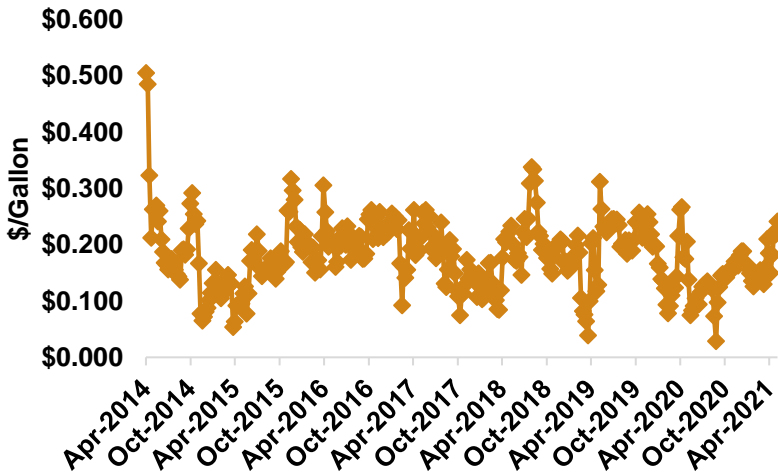

### FOB Ethanol Prices, U.S. Gulf and Santos, Brazil



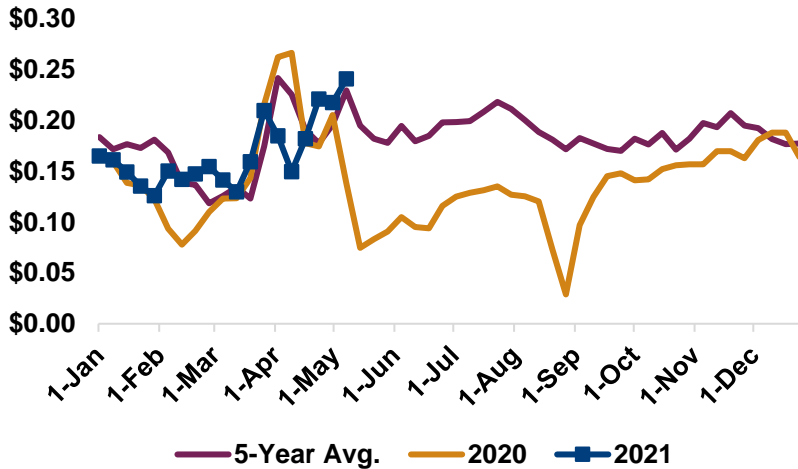

### FOB Santos, Brazil Anhydrous - Hydrous Ethanol Spread



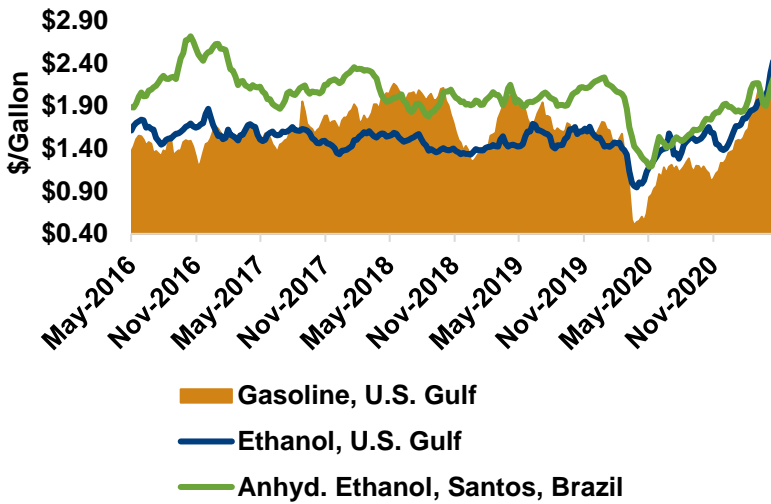

### Seasonal Trends in Brazil's Anhydrous - Hydrous Ethanol Spread



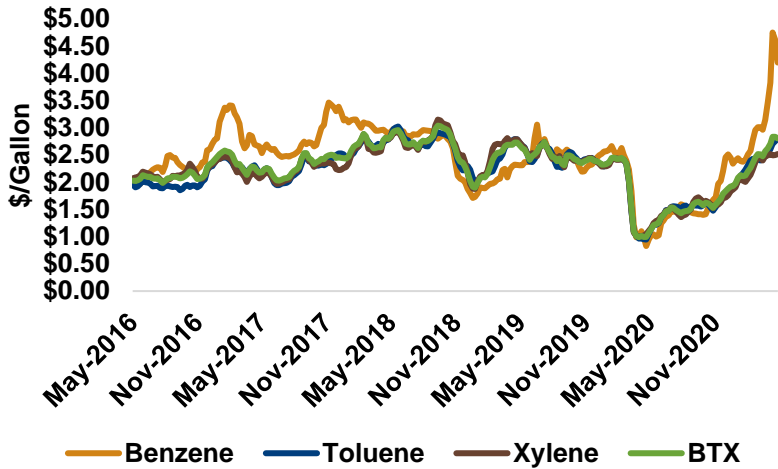

### FOB Gasoline and Ethanol Prices



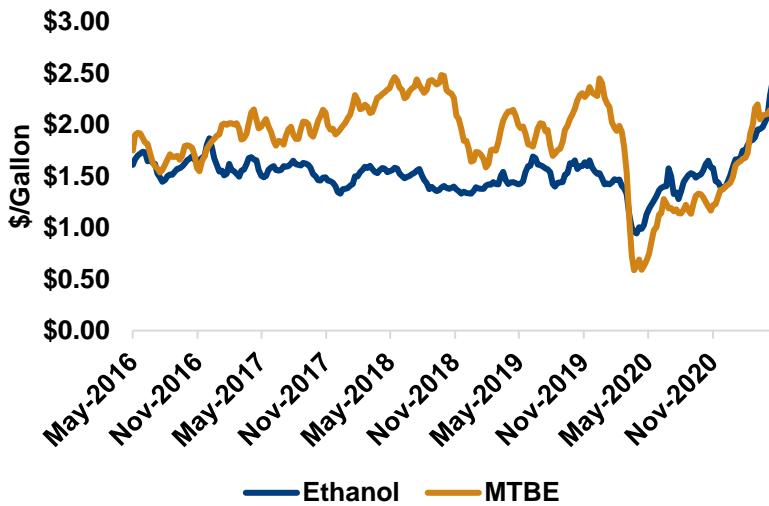

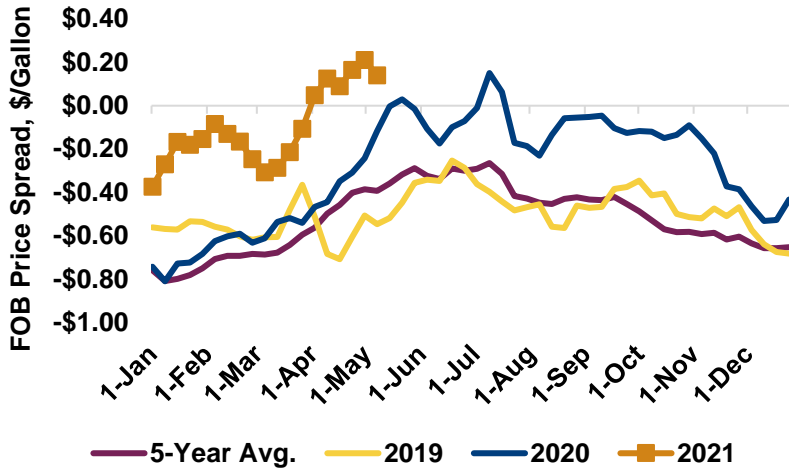
### MTBE versus Ethanol Prices, FOB U.S. Gulf

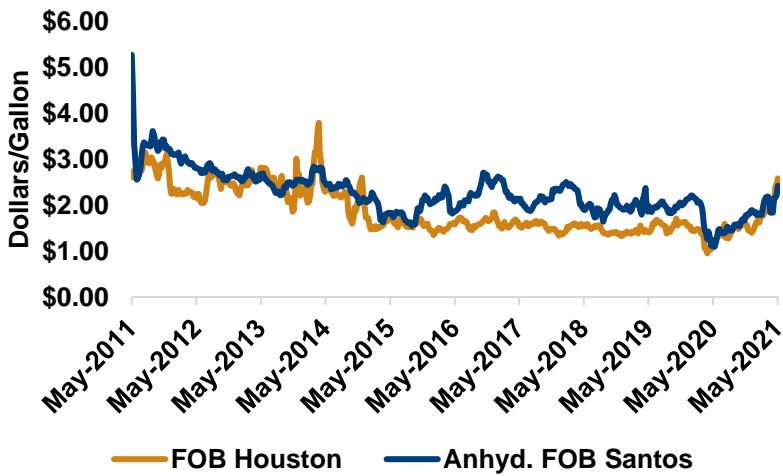


### Seasonal Trends in U.S. Gulf - Santos, Brazil Ethanol FOB Price Spreads

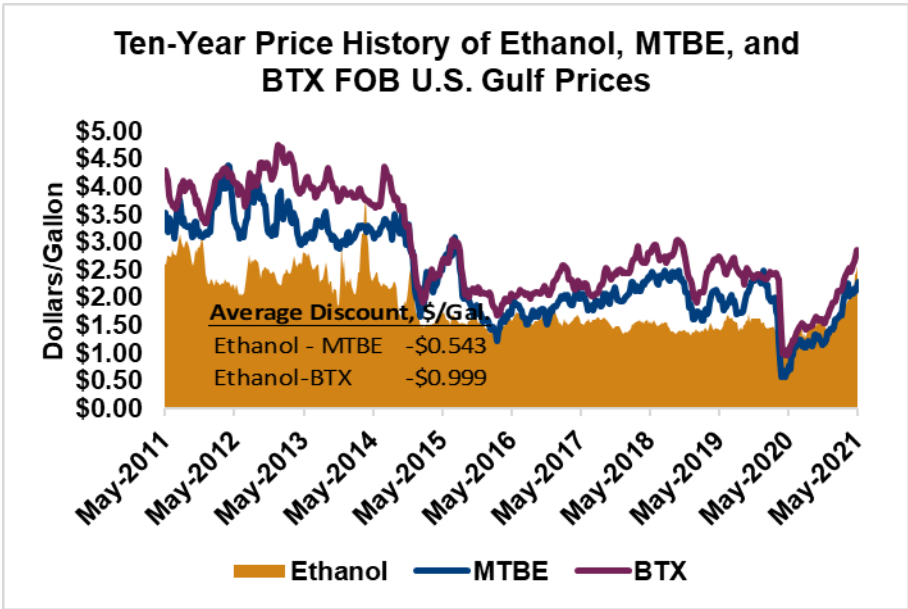
