Market Outlook: U.S. ethanol prices ended last week 2.3 percent lower and extended those losses in early week trading and fell 4.2 percent through Tuesday's close. Midwest wholesale rack ethanol prices were lower to end last week and were down 0.5 percent through Tuesday's market close to their last quote of 48.96 cents/liter (185.35 cents/gallon).

FOB Houston ethanol prices finished last week 3.6 percent lower and are down 1.1 percent through Tuesday's trading from Friday's close. FOB Houston ethanol prices are quoted at 47.23 cents/liter (178.8 cents/gallon). FOB Santos, Brazil anhydrous ethanol prices were lower last week; they are down in early week trading, falling 2.8 percent to 49.64 cents/liter (187.89 cents/gallon) through Tuesday's trading.

The FOB Gulf-Santos, Brazil ethanol spread has narrowed from last week's close through Tuesday's trading and is currently at -2.4 cents/liter (-9.09 cents/gallon).

MTBE prices fell 7.9 percent last week and continued that trend in early week trading to fall 3.4 percent from Friday's close through Tuesday's trading. MTBE's premium to FOB Houston ethanol has decreased from last week's report and stands at 16.29 cents/liter (61.65 cents/gallon).


BTX component prices were sharply lower last week and remained on the defensive through Tuesday's market close: Benzene was down 0.5 percent while Toluene was down 0.3 percent, and Xylene was down 0.3 percent. The estimated weighted average aromatic price is currently 88.87 cents/liter (336.43 cents/gallon), down from last Friday's close. The BTX-Houston ethanol spread widened last week, and the weighted average BTX price is 41.64 cents/liter (157.63 cents/gallon) higher than the FOB Houston ethanol price.

Gasoline and petroleum products were higher last week and continued that trend in early week trade. RBOB futures are up 3 percent to start the week while 84 octane RBOB (Houston) and 87 octane CBOB (U.S. Gulf) gasoline prices are up 3.2 and up 1.5 percent, respectively. WTI futures are 3.5 percent higher at \$73.94/barrel while Brent futures are up 3.5 percent to \$79.26/barrel, from Friday through Tuesday's close.

Liquid tanker rates are 1 percent higher on average this week with offers for the U.S. Gulf to Saudi Arabia seeing the largest gains (up 14 percent). Freight from the U.S. Gulf to India saw the largest declines and is down 6 percent from last week. On average, tanker freight from the U.S. Gulf is up 1 percent this week while freight from the PNW has posted a 3 percent decline. Liquid tanker freight rates from Brazil are up 5 percent, on average, this week. Freight rates across all origins are 17 percent lower than this same week in 2022.


On a cost-and-freight (C&F) basis, offers are mostly lower this week as lower FOB offers for ethanol have offset gains in liquid tanker freight rates. Prices for ethanol C&F to Central America from the U.S. Gulf are down 2.5 percent this week and are down 17.8 percent from this same week in 2022. Values for PNW ethanol to Southeast Asia average \$708.29/MT this week, down 2.9 percent from the prior week and down 22.6 percent year-over-year. That compares to U.S. Gulf to Southeast Asia C&F prices that average \$699.49/MT and are down 2.9 percent from last week and are down 21.8 percent year-over-year. C&F prices for Brazilian ethanol to Southeast Asia are down 1.3 percent from last week.

Rolling 52-Week Ethanol and Gasoline Prices, FOB Houston






Daily Weighted Average BTX and Ethanol Prices, FOB U.S. Gulf






Ethanol as % of Gasoline, FOB U.S. Gulf Prices




FOB Ethanol Prices, U.S. Gulf and Santos, Brazil






Seasonal Trends in Brazil's Anhydrous - Hydrous Ethanol Spread



FOB Gasoline and Ethanol Prices




U.S. Benzene, Toluene, and Xylene Prices and Estimated BTX Value






Seasonal Trends in U.S. Gulf - Santos, Brazil Ethanol FOB Price Spreads



Clean Liquid Tanker Freight Rates to Singapore




Clean Liquid Tanker Freight Rates to the Philippines

Estimated C&F Prices for Ethanol Delivered to India


