Market Outlook: U.S. ethanol prices ended last week 1.8 percent higher and followed that trend further in early week trading and rose 1.2 percent through Tuesday's close. Midwest wholesale rack ethanol prices were higher to end last week and were up 1 percent through Tuesday's market close to their last quote of 49.85 cents/liter (188.72 cents/gallon).

FOB Houston ethanol prices finished last week 1.4 percent higher and are up 0.7 percent through Tuesday's trading from Friday's close. FOB Houston ethanol prices are quoted at 49.03 cents/liter (185.6 cents/gallon). FOB Santos, Brazil anhydrous ethanol prices were lower last week; they are up in early week trading, rising 9.1 percent to 57.88 cents/liter (219.115 cents/gallon) through Tuesday's close.

The FOB Gulf-Santos, Brazil ethanol spread has widened from last week's close through Tuesday's trading and is currently at -8.85 cents/liter (-33.52 cents/gallon).

MTBE prices fell 2.3 percent last week and were weaker still in early week trading to fall 4.4 percent from Friday's close through Tuesday's trading. MTBE's premium to FOB Houston ethanol has decreased from last week's report and stands at 20.71 cents/liter (78.41 cents/gallon).


BTX component prices were sharply lower last week and extended those losses through Tuesday's market close: Benzene was down 1.8 percent while Toluene was down 3.3 percent, and Xylene was down 2.6 percent. The estimated weighted average aromatic price is currently 97.85 cents/liter (370.4 cents/gallon), down from last Friday's close. The BTX-Houston ethanol spread narrowed last week, and the weighted average BTX price is 48.82 cents/liter (184.8 cents/gallon) higher than the FOB Houston ethanol price.

Gasoline and petroleum products were lower last week and pushed lower still in early week trade. RBOB futures are down 2.3 percent to start the week while 84 octane RBOB (Houston) and 87 octane CBOB (U.S. Gulf) gasoline prices are down 0.9 and 0.7 percent, respectively. WTI futures are 1 percent lower at \$77.32/barrel while Brent futures are down 1.1 percent to \$82.05/barrel, from Friday through Tuesday's close.

Liquid tanker rates are 5 percent higher on average this week with offers for the U.S. Gulf to the East Coast of Mexico seeing the largest gains (up 73 percent). Freight from the U.S. Gulf to India saw the largest declines and is down 1 percent from last week. On average, tanker freight from the U.S. Gulf is up 8 percent this week while freight from the PNW is unchanged. Liquid tanker freight rates from Brazil are also steady so far this week. Freight rates across all origins are 18 percent higher than this same week in 2023.


On a cost-and-freight (C&F) basis, offers are mostly higher this week as both freight rates and FOB ethanol offers have climbed higher. Prices for ethanol C&F to Central America from the U.S. Gulf are up 2.3 percent this week and are down 24.2 percent from this same week in 2023. Values for PNW ethanol to Southeast Asia average \$834.09/MT this week, up 8 percent from the prior week but down 13.7 percent year-over-year. That compares to U.S. Gulf to Southeast Asia C&F prices that average \$750.71/MT and are up 1.2 percent from last week but are down 22 percent year-over-year. C&F prices for Brazilian ethanol to Southeast Asia are up 10.3 percent from last week.

Rolling 52-Week Ethanol and Gasoline Prices, FOB Houston



Rolling 52-Week FOB Houston - FOB Santos, Brazil Ethanol Price Spread




Daily Weighted Average BTX and Ethanol Prices, FOB U.S. Gulf






Ethanol as % of Gasoline, FOB U.S. Gulf Prices




FOB Ethanol Prices, U.S. Gulf and Santos, Brazil






Seasonal Trends in Brazil's Anhydrous - Hydrous Ethanol Spread



FOB Gasoline and Ethanol Prices




U.S. Benzene, Toluene, and Xylene Prices and Estimated BTX Value






Seasonal Trends in U.S. Gulf - Santos, Brazil Ethanol FOB Price Spreads




Clean Liquid Tanker Freight Rates to Singapore





