Market Outlook: U.S. ethanol prices ended last week 2.2 percent lower but were unchanged in early week trading through Tuesday's close. Midwest wholesale rack ethanol prices were higher to end last week but were down 0.3 percent through Tuesday's market close to their last quote of 51.3 cents/liter (194.19 cents/gallon).

FOB Houston ethanol prices finished last week 0.9 percent higher but are down 0.8 percent through Tuesday's trading from Friday's close. FOB Houston ethanol prices are quoted at 50.63 cents/liter (191.66 cents/gallon). FOB Santos, Brazil anhydrous ethanol prices were higher last week; they are down in early week trading, falling 1.8 percent to 56.9 cents/liter (215.4 cents/gallon) through Tuesday's close.

The FOB Gulf-Santos, Brazil ethanol spread has narrowed from last week's close through Tuesday's trading and is currently at -6.27 cents/liter (-23.74 cents/gallon).

MTBE prices fell 2.1 percent last week but erased those losses in early week trading to gain 3.6 percent from Friday's close through Tuesday's trading. MTBE's premium to FOB Houston ethanol has increased from last week's report and stands at 18.8 cents/liter (71.17 cents/gallon).


BTX component prices were mixed last week but were weaker through Tuesday's market close: Benzene was down 0.2 percent while Toluene was down 0.8 percent, and Xylene was down 1.3 percent. The estimated weighted average aromatic price is currently 95.4 cents/liter (361.11 cents/gallon), down from last Friday's close. The BTX-Houston ethanol spread narrowed last week, and the weighted average BTX price is 44.76 cents/liter (169.45 cents/gallon) higher than the FOB Houston ethanol price.

Gasoline and petroleum products were higher last week but pulled back in early week trade. RBOB futures are down 2.5 percent to start the week while 84 octane RBOB (Houston) and 87 octane CBOB (U.S. Gulf) gasoline prices are down 3.7 and 2.7 percent, respectively. WTI futures are 1.2 percent lower at \$78.66/barrel while Brent futures are down 1.8 percent to \$82.51/barrel, from Friday through Tuesday's close.

Liquid tanker rates are 1 percent lower on average this week with offers for the U.S. Gulf to the East Coast of Mexico seeing the largest gains (up 12 percent). Freight from the U.S. Gulf to Brazil saw the largest declines and is down 5 percent from last week. On average, tanker freight from the U.S. Gulf is down 1 percent this week while freight from the PNW has posted a 1 percent decline. Liquid tanker freight rates from Brazil are down 1 percent, on average, this week. Freight rates across all origins are 26 percent higher than this same week in 2023.


On a cost-and-freight (C&F) basis, offers are mostly lower this week as both freight rates and FOB ethanol offers have moved below last week's values. Prices for ethanol C&F to Central America from the U.S. Gulf are down 0.9 percent this week and are down 21.8 percent from this same week in 2023. Values for PNW ethanol to Southeast Asia average \$818.21/MT this week, down 1.7 percent from the prior week and down 7.8 percent year-over-year. That compares to U.S. Gulf to Southeast Asia C&F prices that average \$767.17/MT and are down 1 percent from last week and are down 19.7 percent year-over-year. C&F prices for Brazilian ethanol to Southeast Asia are down 0.8 percent from last week.

Rolling 52-Week Ethanol and Gasoline Prices, FOB Houston






Daily Weighted Average BTX and Ethanol Prices, FOB U.S. Gulf






Ethanol as % of Gasoline, FOB U.S. Gulf Prices




FOB Ethanol Prices, U.S. Gulf and Santos, Brazil






Seasonal Trends in Brazil's Anhydrous - Hydrous Ethanol Spread



FOB Gasoline and Ethanol Prices




U.S. Benzene, Toluene, and Xylene Prices and Estimated BTX Value






Seasonal Trends in U.S. Gulf - Santos, Brazil Ethanol FOB Price Spreads




Clean Liquid Tanker Freight Rates to Singapore





