GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$104, down from \$112 the previous week. The FOB Gulf DDGS to corn spread is -\$6.55, up from -\$7.48 last week. Overall U.S. ethanol production averaged 1.082 million barrels per day, down 30,000 BPD week over week.


