The FOB Gulf DDGS to SBM spread for this week was \$94, down from \$104 the previous week. The FOB Gulf DDGS to corn spread is \$5.03, up from -\$6.55 last week. Overall U.S. ethanol production averaged 1.084 million barrels per day, up 2,000 bpd week-on-week while flat versus the same week last year.


