The FOB Gulf DDGS to SBM spread for this week was \$110, up from \$94 the previous week. The FOB Gulf DDGS to corn spread is \$12.12, up from \$5.03 last week. Overall U.S. ethanol production averaged 1.081 million barrels per day, down 3,000 bpd week-on-week but 0.3% higher than the same week last year.


