GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$121, up from \$110 the previous week. The FOB Gulf DDGS to corn spread is \$9.96, down from \$12.12 last week. Overall U.S. ethanol production averaged 1.093 million barrels per day, up 12,000 bpd week-on-week.

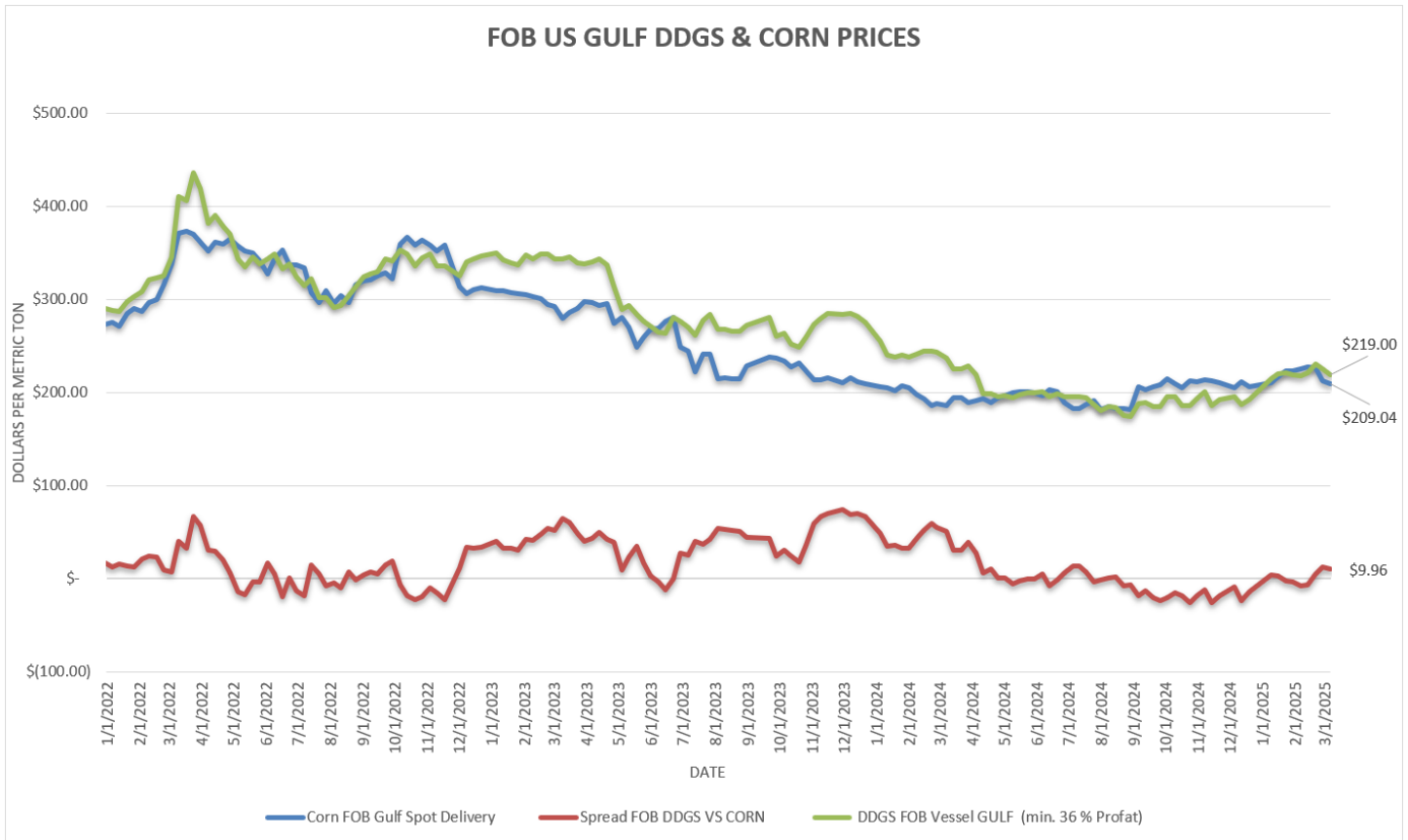
