The FOB Gulf DDGS to SBM spread for this week was \$124, up from \$108 the previous week. The FOB Gulf DDGS to corn spread is \$10.80, down from \$13.82 last week. Overall U.S. ethanol production averaged 1.021 million barrels per day, down 42,000 bpd week-on-week.


