Market Outlook: U.S. ethanol prices ended last week 1.7 percent higher but were mostly steady in early week trading and fell 0.1 percent through Tuesday's close. Midwest wholesale rack ethanol prices were higher to end last week and were up 1.2 percent through Tuesday's market close to their last quote of 50.9 cents/liter (192.67 cents/gallon).

FOB Houston ethanol prices finished last week 0.1 percent lower but are up 1.2 percent through Tuesday's trading from Friday's close. FOB Houston ethanol prices are quoted at 50.49 cents/liter (191.12 cents/gallon). FOB Santos, Brazil anhydrous ethanol prices were higher last week; they are up in early week trading, rising 1.6 percent to 58.89 cents/liter (222.9075 cents/gallon) through Tuesday's close.

The FOB Gulf-Santos, Brazil ethanol spread has widened from last week's close through Tuesday's trading and is currently at -8.4 cents/liter (-31.79 cents/gallon).

MTBE prices rose 4.1 percent last week but pared back that weakness in early week trading to gain 1.8 percent from Friday's close through Tuesday's trading. MTBE's premium to FOB Houston ethanol has increased from last week's report and stands at 2.81 cents/liter (10.64 cents/gallon).


BTX component prices were sharply higher last week and saw mixed trade through Tuesday's market close: Benzene was down 0.1 percent while Toluene was down 0.4 percent, and Xylene was up 0.9 percent. The estimated weighted average aromatic price is currently 70.84 cents/liter (268.15 cents/gallon), up from last Friday's close. The BTX-Houston ethanol spread narrowed last week, and the weighted average BTX price is 20.35 cents/liter (77.04 cents/gallon) higher than the FOB Houston ethanol price.

Gasoline and petroleum products were mostly higher last week but turned lower in early week trade. RBOB futures are down 3.1 percent to start the week while 84 octane RBOB (Houston) and 87 octane CBOB (U.S. Gulf) gasoline prices are down 2.7 and 2.5 percent, respectively. WTI futures are 4.8 percent lower at \$60/barrel while Brent futures are down 4.5 percent to \$62.87/barrel, from Friday through Tuesday's close.

Liquid tanker rates are 3 percent lower on average this week with offers for the U.S. Gulf to Peru seeing the smallest declines (down 2 percent). Freight from the U.S. PNW to Philippines saw the largest declines and is down 4 percent from last week. On average, tanker freight from the U.S. Gulf is down 3 percent this week while freight from the PNW has posted a 4 percent decline. Liquid tanker freight rates from Brazil are down 3 percent, on average, this week. Freight rates across all origins are 5 percent lower than this same week in 2024.


On a cost-and-freight (C&F) basis, offers are mostly higher this week as higher FOB offers for ethanol offset lower freight rates. Prices for ethanol C&F to Central America from the U.S. Gulf are up 1.3 percent this week and are up 6.5 percent from this same week in 2024. Values for PNW ethanol to Southeast Asia average \$745.11/MT this week, down 0.3 percent from the prior week but up 5.2 percent year-over-year. That compares to U.S. Gulf to Southeast Asia C&F prices that average \$739.95/MT and are up 0.9 percent from last week and are up 2.2 percent year-over-year. C&F prices for Brazilian ethanol to Southeast Asia are up 1.5 percent from last week.

Rolling 52-Week Ethanol and Gasoline Prices, FOB Houston



Rolling 52-Week FOB Houston - FOB Santos, Brazil Ethanol Price Spread





Daily Weighted Average BTX and Ethanol Prices, FOB U.S. Gulf




Ethanol as % of Gasoline, FOB U.S. Gulf Prices








Seasonal Trends in Brazil's Anhydrous - Hydrous Ethanol Spread



FOB Gasoline and Ethanol Prices




U.S. Benzene, Toluene, and Xylene Prices and Estimated BTX Value






Seasonal Trends in U.S. Gulf - Santos, Brazil Ethanol FOB Price Spreads




Estimated C&F Prices for Ethanol Delivered to India
