GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$89, down from \$99 the previous week. The FOB Gulf DDGS to corn spread is \$25.43, up from \$19.38 last week. Overall U.S. ethanol production averaged 993,000 barrels per day, down 27,000 bpd week-on-week.

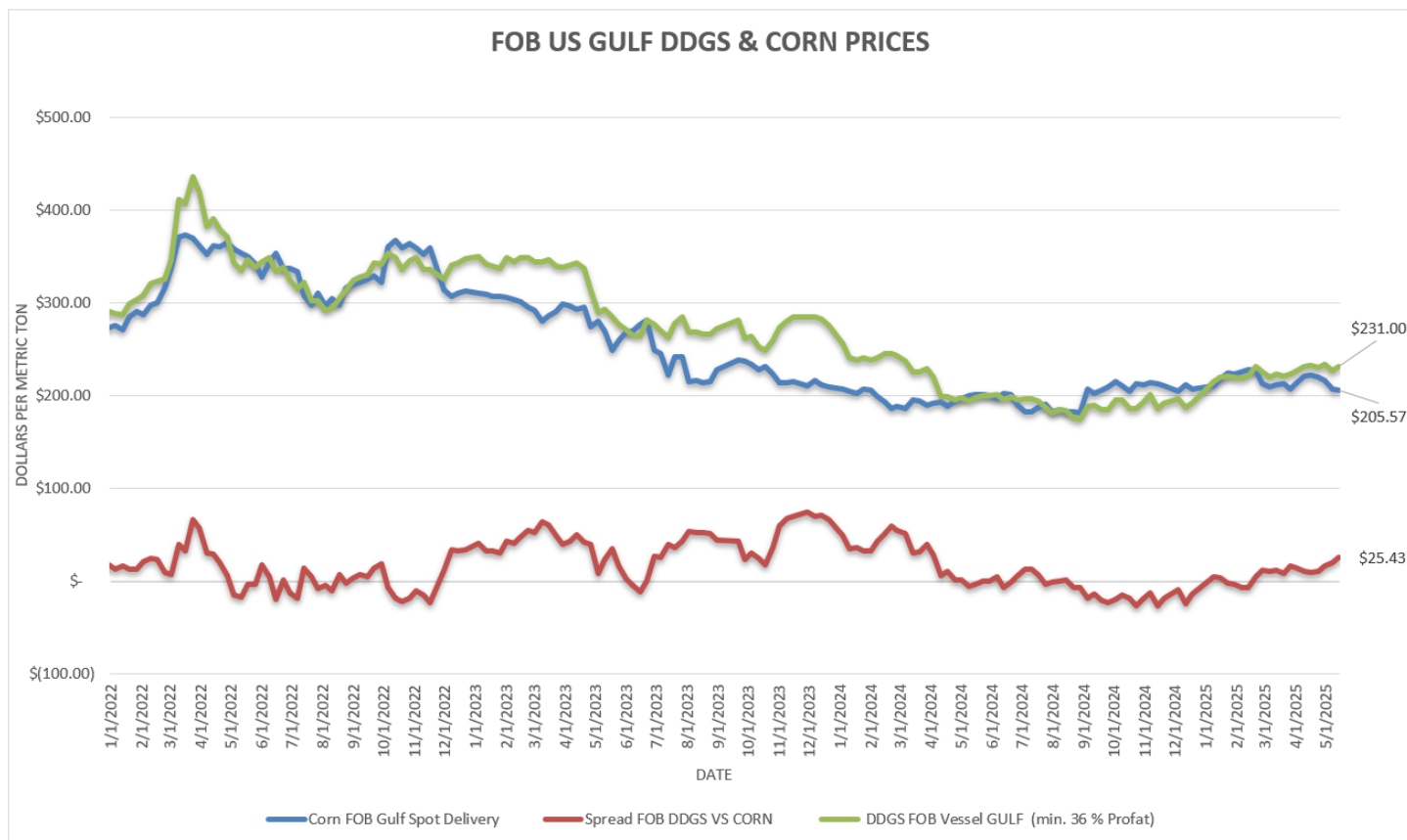
