GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$73, down from \$77 the previous week. The FOB Gulf DDGS to corn spread is \$27.04, down from \$35.56 last week. Overall ethanol production in the United States averaged 1.076 million bpd, down 5,000 bpd week-on-week and 22,000 bpd, or 2% higher than in the same week last year.

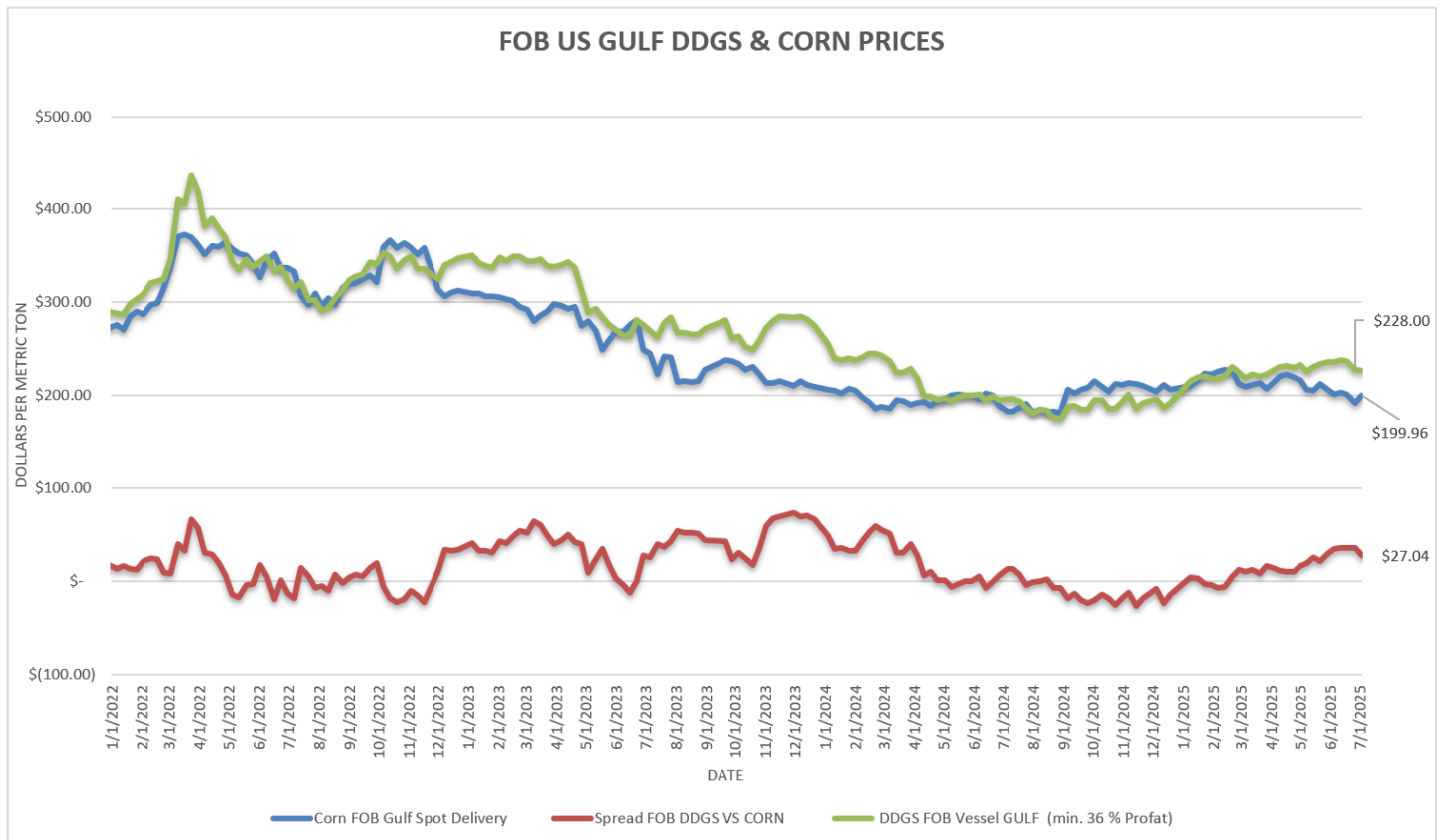
